# **Uniform Policy**



## **Uniform Policy**

Quilpie State College Parents' and Citizens' Association seek our support in ensuring that this policy is practiced throughout the school.

- The school community feels that a focus on uniform is relevant to our task of preparing students for life outside of the school environment and that wearing clothing correctly at school best prepares students for the expectations of future employment.
- We also believe that correct wearing of the school uniform by all students significantly decreases
  the potential for distraction from class work, and the competition and bullying that naturally
  arises when young people dress fashionably.
- Having all of our students in correct uniform also means that we can quickly and readily identify our students from those who should not be in the school grounds.
- On themed dress days, the following conditions still apply: shoes must be enclosed, clothing
  must be sun safe i.e. no string singlets, no short shorts, no belly exposed.

### The uniform requirements are as follows:

#### Day Uniform:

- QSC polo shirt
- Plain black shorts (no logos or prints)
- Joggers
- Ankle or short socks
- QSC bucket hat (red- Primary & Black-Secondary)
- On 1 pre-allocated day each week- Year 10 students are allowed to wear their senior shirts

#### Winter Uniform:

- QSC red jumper
- Plain black tracksuit pants (no logos or prints)

#### Items NOT to be worn:

- Open footwear
- Beanie or similar headwear
- Any clothing with logos or prints
- Tights
- Denim
- Hooded jackets
- Excessive makeup
- Excessive jewellery (beyond- 1 pair of stud or sleeper earrings & 1 watch)
- Facial piercings

<sup>\*</sup> If a student wears thongs, masseurs or sandals to school, the parent will be contacted to bring more appropriate footwear. If the parent is unavailable the student will be unable to complete practical lessons or outdoor lunch break activities for the day.

#### **STAFF RESPONSIBILITIES:**

### **Classroom Teachers and Playground Duty Teachers**

- 1. Monitor the complete/correct/tidy wearing of uniform
- 2. In the case where the student presents out of uniform, teacher must check if the student has a note from their parent regarding reason of being out of uniform. If they don't have a note, they must be immediately sent to the office to trade their non-uniform clothing for a spare school uniform or for parents to be contacted to bring correct uniform to school.
- 3. If students refuse to comply, report on ONESCHOOL and refer to the Principal.
